Regular Board Meeting Minutes of June 9, 2021

BOARD MEMBERS PRESENT: Frank Garza, Don Goodrich, Bruce Olson and Heather Peters

- 1. Meeting call to order/Roll/ Pledge of Allegiance to the Flag: Meeting was called to order at 6:34 p.m. All present stood for the Pledge of Allegiance.
- 2. Public Comments: Dane Wadle-CSDA Field Rep. for Calaveras County spoke to the board that he is trying to get money to special districts due to COVID-19. To date special districts have not received any funds, but CSDA is trying to change that. Supervisor Tofanelli addressed the board stating that something should be done to show this is a memorial district. Dave Reyner-American Legion Commander would like to have the cabinets up to display some items and display items in the hall.
